# <u>In the Matter of Consent Agenda – Director's Report, Treasurer's Report and October 2024 Meeting Minutes:</u>

## In the Matter of Old Business:

Building update – Working through some floor matching issues. Should have Certificate of Occupancy in the second week of December.

### In the Matter of New Business:

**Executive Director Contract Renewal 2025** – Allyson will send her contract to everyone on the board for review. Nathan stated that the salary is the same as when she was hired in April 2023, so this is something to look at. The contract is set up to auto- renew. If anyone has concerns or comments, please email Nathan. The contract will be approved at the December or January meeting.

**8% Innkeepers Tax** – Currently at 5% would like to move to 8%. Will have to go to Commissioners for approval. It was suggested to Allyson to have letters of support from three of the largest entities in the County.

**Co-Working space/rental of offices** – Previous Boone County Chamber President spoke with Allyson and Nathan, and they don't utilize their space the way they need to because they are out more than they are in but they still need office space. They have an interest in possibly letting their building go and renting office space from Discover Boone. Nathan likes the idea of having one or two partners instead of multiple for space rental. The Chamber mentioned that they have a need for a receptionist but maybe only 20 hours a week. Maybe the Chamber and Discover Boone could share employees.
